## Cal Dream Scholarship Fund 2009

### University of California, Berkeley

The Cal Dream Scholarship Fund will award several scholarships of at least \$10,000 per year to academically qualified students in need of financial assistance. However, the amount and number of recipients will be at the sole discretion of the scholarship committee appointed by the scholarship donors and the Liberty Hill Foundation.

#### **ELIGIBILITY CRITERIA**

To be considered for the Cal Dream Scholarship, an applicant must meet all of the following criteria:

1. Meet the requirements of California Assembly Bill 540 (Nonresident Tuition Exemption).
2. Be a current or incoming, full-time undergraduate student attending University of California, Berkeley.
3. Be the child of immigrant parents.
4. Be ineligible for federal and state financial aid and demonstrate financial need.
5. Demonstrate leadership and a commitment to service or activism on campus or in the community.
6. Make every effort to be available for a personal interview should one be required.

#### **GUIDELINES & INSTRUCTIONS FOR APPLICATION PACKETS**

1. Please use standard 8.5" x 11" white paper, printing on one side only.
2. Please do not use any type of fastener or binding other than an envelope (e.g., no staples, paper clips, binder clips, report covers).
3. All applicants must submit the following to be considered (please do not submit additional materials):
  - Completed application form. You must use the attached application form (you may not re-type it or otherwise alter the form in any manner). Please answer every question. If a question does not apply to you, write "N/A".
  - Personal statement (typed, 1-2 pages, double-spaced, 12-point Times New Roman font, 1-inch margins). Please answer one of the following questions:
    - What matters the most to you and why?
    - Describe an achievement you are most proud of and why?

- Two (2) signed and sealed letters of recommendation, one of which must be from a teacher/professor. The authors should be familiar with your academic and/or community service work (no family members or friends) and the letters should be specific as to the author's knowledge of your strengths and abilities and explain why the author is recommending you for a scholarship.
- Transcripts for all high schools and colleges attended. Photocopies of official transcripts and online print-outs of grade reports which include your GPA may be used.

If you are a graduating high school senior, the transcript should include grades for all high school classes (9<sup>th</sup>-12<sup>th</sup>) completed through the 1<sup>st</sup> semester (Fall) of your senior year.

If you are currently a college student, you should submit your high school transcripts as well as your college transcript(s), which should include grades for all college classes completed thus far.

- Résumé, which details your complete work and community service history.
4. All application materials must be mailed together in one envelope. Faxes and emails will not be accepted. Incomplete submissions will not be considered.
  5. Application materials will not be returned.
